### **Rugby World Cup 2023 Terms and Conditions**

PU Prime is the commercial name of Pacific Union (Seychelles) Limited (the "Company", "us", "we", "our", "ours" or "ourselves" as appropriate) and is authorised and regulated by the Financial Services Authority of Seychelles under number SD050. The Company registered in Seychelles and located at 9A, CT House, Providence, Mahe, Seychelles.

The "Rugby World Cup 2023 Terms and Conditions" is an integral part of the "PU Prime Client Agreement" and provisions set herein are considered as an annex of all "PU Prime Client Agreement" and they should be read in conjunction.

#### 1. Conditions of Eligibility

- i. Subject to, and without prejudice to, all other Terms and Conditions, the offer is available to PU Prime's Clients who have satisfied the Eligibility Criteria for the offer ("Eligible Clients") as set out in the sections following hereinafter.
- ii. The "Rugby World Cup 2023" may be offered by PU Prime to clients who open real trading accounts (meaning not demo) with PU Prime, in cases where such clients are referred to PU Prime via specific websites and/or social network sites in the context of certain specific promotions, and/or surveys that PU Prime may be running from time to time on such specific websites and/or social network sites.
- iii. PU Prime, at its absolute discretion, offers the "Rugby World Cup 2023" to Eligible Client(s) specific countries/regions, as it deems appropriate and for the duration determined by PU Prime.
- iv. Only persons who can form legally binding contracts under the laws applicable in their country of residence may participate in the "Rugby World Cup 2023". Without limiting the foregoing, participation in the "Rugby World Cup 2023" is not allowed for persons under the age of 18 or otherwise under the legal age in their country of residence ("Minors"). If you are a minor, you cannot participate in the "Rugby World Cup 2023".
- v. Participation of "Intermediaries/Related Parties" in the "Rugby World Cup 2023" is prohibited. If the registration and/or trading data of a participant in the "Rugby World Cup 2023" corresponds with the registration and/or trading information, including but not limited to IP address, of another participant in the "Rugby World Cup 2023", PU Prime reserves the right to regard this matching as a reason for immediate disqualification. For the purposes hereof, the term "Intermediary (ies)/Related Party (ies)", when used in these Terms & Conditions, unless the context otherwise requires, shall mean to include any person or entity bearing a relationship with any participant in the "Rugby World Cup 2023", including, without limitation:
  - Family members or relatives of the participants, such as siblings, spouses, ancestors, lineal descendants, and collateral descendants.
  - Person or entity, whom any participant in the "Rugby World Cup 2023", directly
    or indirectly through one or more intermediaries, controls, or whom, directly or



indirectly, through one or more intermediaries, is controlled by, or is under common control with any participant in the "Rugby World Cup 20232"; for purposes of this definition, the term "control" (including, with correlative meaning, the terms "controlled by" and "under common control with"), as used with respect to any participant in the "Rugby World Cup 2023", shall mean the possession, directly or indirectly through one or more intermediaries, of the power to direct or cause the direction of management policies of such person or entity, whether through ownership of voting securities or otherwise.

 Similarly, persons associated in any manner whatsoever with PU Prime and/or with the specific websites and/or social network sites on which PU Prime may be running from time-to-time certain specific promotions, contests, and/or surveys, in the context of which access to the "Rugby World Cup 2023" is offered, are not allowed to participate in the offer.

### 2. Promotion "Rugby World Cup 2023" Terms and Conditions

- i. This promotion is open to both new and existing PU Prime App clients. By participating in this promotion, clients acknowledge that they have read and agreed to be bound by these Terms and Conditions and PU Prime's General Terms and Conditions.
- ii. By opening a new account and/or participating in this promotion, the client acknowledges they have read and agree to be bound by these Terms and Conditions and PU Prime's Client Agreement.
- iii. The "Rugby World Cup 2023" promotion consists of various in-app activities to engage PU Prime App users. This promotion applies to both demo and live accounts, however only live account users will be eligible to redeem and utilise the rewards. The reward(s) such as cash, cash vouchers, trade-loss vouchers, credit bonus vouchers will be awarded to clients who have participated in the in-app activities and met the specific criteria.

### 2.1 Ruck-n-Roll (Participate and win)

- During the entire campaign period, clients have the opportunity to participate in predicting the outcomes of a total of 48 matches (comprising 40 Group matches, 4 quarter-final matches, 2 semi-final matches, 1 runner-up Bronze final match, and 1 final match).
- ii. Guessing for each match will commence at least 24 hours before the scheduled kick-off time of the match.



- iii. Clients may win up to \$120 in-app trading credit for participating in match prediction.
- iv. The credit bonus awarded to the client will be determined by the number of participants in predicting the outcomes of the matches, as outlined in the table below:

- v. Each participant can redeem up to 12 x \$10 Credit Bonus Vouchers.
- vi. The first match to guess will begin on 8 September 2023 and the last match to guess will be on 28 October 2023.
- vii. Every credit bonus earned during the entire Rugby World Cup 2023 campaign is subject to specific usage and withdrawal prerequisites.

#### 2.2 Quick Tap to Win (Predict upcoming matches)

- i. Guessing for each match will commence at least 24 hours before the schedule kick-off time of the match.
- ii. The outcome of the match will be updated by the company within 48 hours after the match has ended.
- iii. In the event that the participant correctly anticipates the match outcome, the main page line-up UI will display an indicator of "Correct". Conversely, if the prediction is inaccurate, the indicator will show "Wrong".
- iv. Participants are eligible to receive additional rewards upon achieving specific numbers of correct predictions. Refer to the table below for details on each accomplishment.

- v. Each participant can redeem up to 10 x \$5 Trade-loss Vouchers.
- vi. Once participants reach the designated milestones, they can access the "Achievement" tab to view their respective prizes and accomplishments.

### 2.3 Mark Your Winner (Guess the winner of Rugby World Cup 2023)

- i. "Mark Your Winner" page can be accessed from the main page of the "Rugby World Cup 2023" promotion.
- ii. Each participant is allowed to select one winning team and is unable to change their champion selection once it has been confirmed.
- iii. The last day to participate in "Mark Your Winner", is on 13 October 2023 before Quarter Final.
- iv. The announcement of the winner of Rugby World Cup 2023 will take place within 48 hours after the final match has ended. The final match of Rugby World Cup 2023 is scheduled to kick off on 29 October 2023.
- v. Participants who correctly predict the winner of Rugby World Cup 2023 will be awarded additional prize(s): 10 Trade-loss vouchers worth \$5 each.

### 2.4 Share to win (Share activity with friends and stand a chance to win via lucky draw)

i. On Facebook platform, clients can participate in the lucky draw by sharing the promotion content, tagging 3 friends, and mentioning PU Prime Facebook official account (@ PU Prime). By completing these actions, clients become eligible to win a \$100 cash voucher. Alternatively, clients can access the in-App dashboard and



Achievement tabs to click the "Share" button and engage in the promotion.

- ii. Two (2) winners will be randomly selected and announced on a weekly basis, subject to participation rate.
- iii. The winners of this lucky draw will have the cash vouchers added to their balances five days after the end of the promotion, specifically on November 21, 2023. It's important to note that if the number of participants is less than 20, the draw will not be carried out.

- Vouchers must be redeemed within the campaign period plus an additional 14 days: from 9 September 2023 to 16 November 2023. The promotion tab (UX/UI) of Rugby Campaign will be disabled on 16 November 2023 and the redeem function on the page will no longer be available.
- 6 Redeemed Voucher can be found in the Coupon Management In-App page. The vouchers and credits validity of 30 days from the end date of redemption period (Campaign period + 14 days + 1 month). Any unused vouchers will become unavailable upon expiration on 16 December 2023.
- 7 To view the credit bonus, trade-loss vouchers, and cash voucher collected during the Rugby World Cup 2023, clients can go to the "Achievement" tab, which can be accessed directly via the promotion page.

#### 8 Trading Credits:

- i. To use the trading credits won through this Rugby World Cup 2023, the client must deposit minimally USD 100 (cumulative) and trade a minimum of 2 standard lots of currencies, metals, crude oil spot or crude oil futures products, during the promotion period, 8 September 2023 to 29 October 2023.
- ii. Trading credits will be credited to the client's account within 24 business hours after redeeming the voucher. If the client's account is not denominated in USD, we will convert the credit amount using the following method:

- iii. Clients are unable to withdraw the credited amount as trading credit. However, any profits or losses incurred while trading using the credit amount will be reflected in the client's account balance.
- iv. Clients have the flexibility to withdraw any profits they generate from the trading credit at their convenience. However, it's important to note that withdrawing funds will lead to the proportional deduction of their credit bonus. Transferring funds between MT4 trading accounts is also considered a withdrawal action. If a client submits a withdrawal application, regardless of whether the withdrawal is ultimately successful or not, the credit bonus will be deducted based on the system's logic.

- ii. The offset trading loss amount of the selected order will be reflected under the "Balance" within 24 hours after using the Trade-Loss voucher.
- iii. The Trade-Loss voucher can only be used on trades that are closed after the collection of the voucher and each order can only apply one Trade-Loss voucher.
- iv. Trade-Loss vouchers cannot be used on Swaps and Spreads.
- 10 The match schedules for the Rugby World Cup 2023 displayed within PU Prime App are subject to changes by the organiser, without any prior notice.
- 11 PU Prime is not associated in any way with the Rugby World Cup 2023 organisers, sponsors, associations, or representing any of the teams for Rugby World Cup 2023.

- 13 In the event of duplicate submissions, submission of inaccurate or falsified information, suspected misconduct, fraud, abuse, or violation of the Terms and Conditions, PU Prime may cancel, modify, or reverse any rewards or promotional incentives, and withdraw the eligibility of any participant at its absolute discretion. #### **General Terms and Conditions:**

- i. Promotion area: Except for Mainland China and/or as per the discretion of the Company.
- ii. This promotion is open to existing and new Clients of PU Prime.
- iii. "Rugby World Cup 2023" participation Scope: Clients registered through IB (Introducing Broker) are eligible to take part. However, IB's own trading accounts are not eligible for the promotion. Similarly, clients linked to an Affiliate can participate, but trading accounts opened through an Affiliate's own link are ineligible. Cent accounts are not eligible for participation. PAMM and MAM participants need to open additional accounts to join the promotion.
- iv. The "Rugby World Cup 2023" is available only for Standard Account and Islamic Standard Account type.
- v. If there are multiple trading accounts under the same client's name, only one eligible trading account can participate in this promotion.
- vi. Only a new deposit during the promotion can apply for the credit bonus. A new deposit does not include the funds transfer between the accounts under the same name (internal transfer) and the fund transfer from the commission account, refer friends bonus, funds to make up the exchange difference, or cash adjustments.

- xii. PU Prime reserves the right to alter, amend or terminate the "Rugby World Cup 2023" or any aspect of it at any time without having to compensate anyone for that. Prior notice of such changes will be given to clients. Please note that taking part in the "Rugby World Cup 2023" constitutes acceptance and agreement to abide by any such alterations, amendments and/or changes.
- xiii. Any indication or suspicion, in the PU Prime's sole discretion, of any form of arbitrage (including but not limited to risk free profiting), abuse (including but not limited to participant's trading activity patterns that indicate that the participant solely aims to benefit financially from the Trading Bonus without being genuinely interested in trading in the markets and/or taking market risk), fraud, manipulation, cash-back arbitrage connected to a trading bonus or any other forms of deceitful or fraudulent activity, will nullify all previous trading bonuses of the Eligible Client's real trading accounts with PU Prime and/or any and all transactions carried and/or profits or losses garnered therein.
